2021 Budget Hearing

2021 Budget and Resolution, Ordinance Resolution, Levy Certification

Mark opened the Budget Hearing at 12:01 pm. Purpose of the hearing was to consider and adopt the 2021 Budget and relevant documents.

Laurie provided an update:

- FOL did approve donating unused past donations totaling \$25,372 over past three years in addition to a \$12,000 commitment for 2021;
- \$50,000 transfer from Dedicated Reserves included in the Operating Budget;
- 1.86% increase over 2020 for normal operating expenses;
- transfer to Bond Fund for interest payments in 2021;
- 2021 budget as presented was balanced;
- Laurie will be working on 2020 budget amendments to present at December Board meeting; may tap into unused carryover monies; more details will be provided at December meeting;
- Spring Street property costs currently unknown as property acquisition has not yet closed; Laurie provided some estimated costs (including a part-time development director) but these will need to be addressed in budget amendments later in 2021 as costs become better known; discussion developed

 - Dedicated Fund
 - o LTGO Bond Fund
- Project Fund, Technology, Facilities (all zero as no activity at this time)
 Laurie reported that no input was received from the public. Budget hearing was closed at 12:28 pm.
 - **MSC** Fred Henley moved and Barbara Sharp seconded to approve Resolution #6-2020 setting the final budget for the year 2021 as submitted. Carried.
 - **MSC** Barry Jacobson moved and Barbara Sharp seconded to approve Resolution #5-2020 authorizing the tax levy for the 2021 tax year as presented. Carried.
 - **MSC** Karen Vedder moved and Fred Henley seconded to authorize Library Director Laurie Orton to certify the levy amount to be collected in 2021. Carried.
